

CHAPTER 104 - FEES, LICENSES AND PERMITS

A. PURPOSE. With normal operations of the City, certain costs are associated with the ordinances and providing for the welfare of the community. To help defray the costs the City shall charge for certain services as set forth in this Chapter. This Chapter shall serve as the enabling document for setting the dollar amount for licenses, permits and fees.

B. SETTING OF FEES, LICENSES AND PERMITS. All dollar amounts for fees, licenses and permits shall be set by the City Council and amended from time to time as deemed necessary.

C. FEES. The following is a list of services for which fees will be charged. This list is not intended to be all inclusive, and may be added to from time to time.
